

AMENDMENT #1 TO CONTRACT EMPLOYMENT AGREEMENT

Dina Crown Psychiatric Nursing Services

This amendment #1 is to the Agreement between Yamhill County, a political subdivision of the State of Oregon, acting by and through its Health and Human Services Department, Adult Behavioral Health Division (hereinafter "Agency"), and Dina Crown, R.N., an individual, 1766 NW Cottonwood Drive, McMinnville, OR 97128 (hereinafter "Crown").

- A. Agency and Crown are parties to that certain agreement dated as of December 18, 2014, (the "Underlying Agreement") pursuant to which Crown provides professional psychiatric nursing health services to clients of Agency as directed by Agency's Health and Human Services Director or designee.
- B. Agency and Crown now desire to amend the Underlying Agreement upon the terms and conditions as more particularly set forth herein below.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein below and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the parties hereto, Agency and Crown, intending legally to be bound, hereby agree as follows:

1. Section C Paragraph 4 of the Underlying Agreement is hereby amended to extend the contract term through June 30, 2015.
2. The balance of the Underlying Agreement remains unchanged.
3. Ratification. Except as otherwise expressly modified by the terms of this Amendment #1, the Underlying Agreement shall remain unchanged and continue in full force and effect. All terms, covenants and conditions of the Underlying Agreement not expressly modified herein are hereby confirmed and ratified and remain in full force and effect, and constitute valid and binding obligations of Agency and Crown enforceable according to the terms thereof.
4. Authority. Agency and Crown and each of the persons executing this Amendment #1 on behalf of Agency and Crown hereby covenants and warrants that: (i) such party has full right and authority to enter into this Amendment #1 and has taken all action required to authorize such party (and each person executing this Amendment #1 on behalf of such party) to enter into this Amendment #1, and (ii) the person signing on behalf of such party is authorized to do so on behalf of such entity.
5. Binding Effect. All of the covenants contained in this Amendment #1 shall be binding upon and shall inure to the benefit of the parties hereto and their respective heirs, legal representatives and permitted successors and assigns.

6. Counterparts. This Amendment #1 may be executed in multiple counterparts, each of which shall be an original, but all of which shall constitute one and the same Amendment #1.
7. Recitals. The foregoing recitals are intended to be a material part of this Amendment #1 and are incorporated herein by this reference.
