THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY (“the Board”) sat for the transaction of county business in combined session on May 16, 2024, at 10:00 a.m. in Room 32 of the Yamhill County courthouse, and in a virtual meeting via Zoom, Commissioners Lindsay Berschauer, Kit Johnston, and Mary Starrett being present.

Also present were Ken Huffer, County Administrator; Justin Hogue, Deputy County Administrator; Christian Boenisch, County Counsel; Gioia Goodrum, Economic Development; and Bailey Barnhart, BOC Staff. Nohely Barajas-Montalvo, Legal Assistant participated via Zoom.

Guests: Mike Morris; Bubba King; Janet Lee Redmond; Adriel Person; and Joshua Todd. Lee Schrepel; Nicole; and Kris Bledsoe participated via Zoom.



I. OTHER BUSINESS (Add-ons and non-consent items):

1. **B.O. 24-137** - Consideration of approval of proposal from Camp Fire Columbia for Summer Enrichment Program in McMinnville in the amount of \$291,443.89, for summer 2024 and summer 2025.

Gioia Goodrum participated in afterschool care discussions reviewing McMinnville School District's partnership with Kids on the Block (KOB). Ms. Goodrum stated that Camp Fire Columbia is taking over the management of the KOB program which is nearly out of funding and has no intention to seek further fundraising for the program. Camp Fire Columbia is seeking funding for their summer enrichment program to transition away from KOB and to establish a new partnership with the McMinnville School District and the City of McMinnville. Joshua Todd stated CFC prioritizes enrollment for foster, low income, BIPOC, and other families in need. Between 2021-& 2024, CFC has enrolled 500 students in Yamhill County. Adriel Person of CFC added that there is a rollover option for families that want to continue the program year to year. Their summer enrichment budget covers 60 youths for 2024-25 in one location. Ms. Person said added benefits to families include full day care and flexible program packages, as well as bilingual staff. Mr. Todd noted that while staffing is difficult overall in the childcare sector, McMinnville is an easier recruitment market and outlined available employee benefits. Mr. Todd said plans included fundraisers to support a McMinnville based program and added that out of KOB's remaining funds, it has committed \$100k to the current CFC fiscal year with the remaining funds being applied to the 2025 summer. Commissioner Berschauer moved approval of item I1. Commissioner Johnston recommended funding the program for one summer in the amount of \$189,000. He also recommended that any remaining childcare ARPA funding be awarded to George Fox University. After discussion, the motion passed, Commissioners Berschauer, Johnston, and Starrett voting aye.
