

AMENDMENT No. 1 TO YAMHILL COUNTY FOR YAMHILL COUNTY TRANSIT SERVICES

Board Order 23-71

THIS AMENDMENT is made and entered into this 15th day of August 2024, by and between the YAMHILL COUNTY, a political subdivision of the State of Oregon, acting by and through Yamhill County Transit Area (YCTA) and Nelson/Nygaard Consulting Associates (Consultant) located at 621 SW Morrison Street, Suite 1450, Portland, Oregon 972045 (collectively, the “Parties”).

WHEREAS, The Parties executed a services contract on February 23, 2023 pursuant to Board Order No. 23-71 for the **Bus Stop Improvement/Installation Project**. (the “Contract”); and

WHEREAS, The Parties now wish to amend the Contract to extend the term of the agreement and to increase the not to exceed amount; and now, therefore

THE PARTIES hereby agree to amend the Contract as follows (new language is indicated by underlined font and deleted language is indicated by strike-out font):

1. The section entitled “**Section 1 Effective Date.**” is amended to read as follows:

The term of this Agreement is from May 1, 2022, through June 30, ~~2025~~, 2026 unless terminated in accordance with Section 5 below. It is understood by both parties that no commitments have been or are made by either party beyond the termination of this Agreement.

2. The section entitled “**Section 4 Payment.**” is amended to read as follows:

County agrees to pay Consultant for the services provided under this Agreement ~~for Phases 1, 2, and 3 of the bus stop installation \$158,329.00 for the bus stop improvement project~~ \$245,000. This does not include the optional tasks outlined in the proposal. No minimum number of hours is guaranteed by this Agreement. The maximum amount to which the County is obligated to pay under this Agreement is ~~\$175,000~~ \$245,000. Yamhill County shall make payment to consultant no later than the 30th day of the month following receipt and approval of an itemized statement for Services provided in the previous month.

Except as expressly amended above, all other terms and conditions of the original contract are still in full force and effect. The Contractor certifies that the representations, warranties, and certifications contained in the original contract are true and correct as of the effective date of this Amendment and with the same effect as though made at the time of this Amendment.
