RE: Fleet Surplus

BACKGROUND:

Below is a list of items that have come from the Fleet Department that requires surplus by the Board.

- P-269 is a 2012 Dodge Charger sheriff patrol vehicle that was involved in a motor vehicle accident with heavy front-end damage and is a total loss with an estimated repair cost of \$15,635.80. Estimated value \$1000.
- 90-82 is a 1990 International Flush Truck that has timed out and needs repaired. This vehicle has been replaced. Estimated value \$5000.
- 97- 54 is a 1997 Freightliner FLD120SD has timed out due to age and mileage. This vehicle has been replaced. Estimated value is \$40,000.00.
- 01-58 is a 2001 Freightliner T/A tractor. It has timed out and is no longer needed for everyday operation. This vehicle has been replaced. Estimated value \$27,500.
- 06-19 is a 2006 Chevrolet Silverado that has timed out by age and by mileage and needs mechanical repairs. This vehicle has been replaced. Estimated value \$5,688.50.
- P-050 is a 2008 Ford F-350 Dually that has timed out and by mileage. Estimated value is \$4,000.00.
- P-108 is a 2008 Ford F-350 2x4 that has timed out by age and mileage. Estimated value is \$4,500.00.
- P-029 is a 2013 Ford Fusion that has timed out by age. Estimated value is \$4,200.00.
- P-072 is a 2011 Ford Fusion that has timed out by age. Estimated value is \$4,000.00.
- P-136 is a 2006 Dodge Caravan that has timed out by age. Estimated Value is \$2,500.00.
- P-289 is a 2016 Ford Explorer Pursuit AWD that has timed out by mileage. Estimated value is \$4,100.00.
- P-291 is a 2016 Ford Explorer Pursuit AWD that has timed out by mileage. Estimated value is \$4,100.00.

- P-293 is a 2017 Ford Explorer Pursuit AWD that has timed out by mileage. Estimated value is \$4,300.00.
- P-070 is a 2008 Ford Fusion that has timed out by age. Estimated value is \$2,500.00.
- P-128 is a 2007 Ford E-350 that has timed out by age and mileage. Estimated Value is \$6,000.00
- P-137 is a 2011 Ford Fusion that has timed out by age. Estimated Value is \$4,000.00

Note: Sheriff patrol vehicles are typically replaced at 140,000 miles.

Approve the surplus of the vehicles from list above to be sold through PublicSurplus.com per Ordinance 499.
