

Stocking Requirements

Please note that only a few specific sites qualify for the “FX” site class. Examples of these include large rock outcrops and swampy areas within forestland areas.

Who Determines Designated Forestland Requirements?

The Oregon Revised Statutes and Oregon Administrative Rules provide the requirements for land to be specially assessed as designated forestland.

[ORS 321.358](#) and [OAR 150-321-0340](#) specifically deal with the requirements for DFL. These requirements generally fall into three categories: acreage, species, and stocking.

Minimum Area for Designation

The area to be designated as forestland must be at least two contiguous acres under common ownership.



Stocking Requirements

Minimum stocking requirements are governed by the Forest Practices Act ([OAR 629-610-0000 through 629-610-0090](#)) and [ORS 527.710](#).

Species Type

The trees growing on land designated as forestland must be of a marketable species. A marketable species meets the following criteria ([OAR 629-610-0050](#)):

- Is ecologically suited to the planting site
- Is capable of producing wood products suitable in size and qualify for production of lumber, sheeting, pulp, or other hardwood products
- Must be marketable in the foreseeable future.

Species that are Particularly Ecologically Suited to Yamhill County

- Douglas Fir
- Grand Fir
- Willamette Valley Ponderosa Pine
- Western Red Cedar
- Western Hemlock
- Noble Fir



Acceptable Hardwood Species

Approximately 20% of your total forestland may comprise of hardwoods unless otherwise approved by a forester.

- Big Leaf Maple (trees or managed clumps)
- Red Alder (trees or managed clumps)
- Black Cottonwood
- Oregon Ash
- Oregon White Oak
- Pacific Dogwood
- Pacific Madrone
