9 ARMSTRONG, TED LOPUSZYNSKI and ROBIN J. HAMBLET being present.

10 The Yamhill County Board of Commissioners hereby ordains
11 as follows:

12 That § (4.4) of Ordinance No. 274 is hereby amended to
13 read as follows:

14 4.4--LATE LICENSE FEE. Any owner or keeper of a dog
15 who fails to procure or pay for a license within the time limits
16 required by this Ordinance in any year shall pay a delinquent
17 payment for such failure in the sum of Twenty-five and no/100
18 Dollars (\$25) for each dog provided that, in the case of a
19 kennel, the failure to procure a valid license as required shall
20 subject that kennel to a delinquent license fee of Ten and no/100
21 Dollars (\$10) for each dog on the premises at the date of the
22 violation if said dogs are not otherwise exempt from this
23 Ordinance. Such fee shall be in addition to the regular license
24 fees and shall be paid at the time of the issuance of the license
25 or licenses.
