THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY ("the Board") sat for the transaction of county business in formal session on February 16, 2012, at 10:00 a.m. in Room 32 of the Courthouse, Commissioners Leslie Lewis, Kathy George, and Mary P. Stern being present.

Also present were Laura Tschabold, County Administrator; Chuck Vesper, Deputy County Administrator; Rick Sanai, County Counsel; Denise Bacon, candidate for commissioner; Scott Cimatl, Linfield student; Mike Schorn and Don Holmboe, Portland Karting Association.

Commissioner Lewis called the meeting to order at 10:00 a.m.
