

Ms. George moved to accept the resignation. The motion passed, Commissioners Stern, Lewis, and George voting aye.

E. PUBLIC HEARINGS:

1. <u>B. O. 08-172</u> - Receipt of public comment regarding a mass gathering permit application for the 2008 Memorial Weekend Boat Races at Rogers Landing and a fee waiver request, applicants Newberg Boat Club and Columbia Outboard Racing Association. [Mass gathering permit and exclusive use request approved, fee reduced to \$250.]

John Gray stated that this is the same request as in previous years. He noted that last year the Board waived all but \$250 of the fee in order to cover the county's costs.

Ms. Stern opened the public hearing.

Richard Baker stated that this is the 60th anniversary of the Newberg Boat Club and they are proud to put on this event. Ms. Lewis noted that Parks Coordinator Ken Huffer had shared positive comments about last year's event and the good working relationship that exists between the county and the applicants. Mr. Baker agreed with Mr. Huffer's comments.

Ms. Stern closed the public hearing.

Ms. Lewis moved to reduce the fee from \$965 to \$250. The motion passed, Commissioners Stern, Lewis, and George voting aye.

Ms. George moved approval of the mass gathering permit and exemption under the Parks Ordinance for exclusive use of Rogers Landing as requested. The motion passed, Commissioners Stern, Lewis, and George voting aye. Ms. Lewis stated that the Boat Club does a wonderful job and the event is good for Newberg and its businesses.


