1.     **B.O. 16-57** - Approve Service Element Prior Authorization (SEPA) Approval Unit #7562047 for Intergovernmental Agreement #148087 between HHS Developmental Disabilities and the Department of Human Services (DHS), total amount of \$12,000,000 retroactive to July 1, 2015 through June 30, 2017.
