# SITTING FOR THE TRANSACTION OF COUNTY BUSINESS

THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY ("the Board") sat for the transaction of county business in formal/informal session on April 14, 2011, at 10:00 a.m. in Room 32 of the Courthouse, Commissioners Mary P. Stern, Leslie Lewis, and Kathy George being present.

Also present were Christian Boenisch, Deputy County Counsel; Pat Anderson, Human Resources; Mike Brandt, Planning Director; Stephanie Armstrong, Associate Planner; Tim Loewen, Juvenile Director; Scott Paasch, Cliff Toney, and Jeff Hindley, Juvenile Detention; Hannah Hoffman, News-Register; Joseph Gall, 1156 SW Westvale St, McMinnville; and Zachary Geary, 1951 Oleander Court.

Commissioner Stern called the meeting to order.

PUBLIC COMMENT: This thirty-minute time period is reserved for public comment A. on any topic other than a quasi-judicial land use matter or other topic scheduled for public hearing. Unless extended or restricted by the Chair or majority of the Board, public comment will be limited to three minutes per person.

Joseph Gall referred to his previous petition to the Board for redress of grievances related to his property taxes and presented a written claim for compensation and prosecution of recalcitrant county employees. He requested additional time to present his testimony. Ms. Stern asked him to submit his written claim and said that the Board would provide a written response. In response to a question from Mr. Gall about Ms. Tschabold's authority to fire Rick Sanai, Ms. Stern explained that the Board has the authority to hire and fire the County Administrator and County Counsel, while Ms. Tschabold has authority over all other positions.

Juvenile Corrections

B. O. 11-192 - Consideration of authorizing the Juvenile Corrections Division to proceed with the Amity House Remodel Project, contingent on approval by the County Counsel's Office.

Cliff Toney and Jeff Hindley discussed an opportunity to have the youth fix a house that had come into the county's possession as a result of tax delinquency. They explained that this would teach the youth job skills and work ethic that would help prepare them to enter the job market. Christian Boenisch said that he is still working with the Assessor's Office to clarify the expectations for the proceeds that would come from the sale of the property.


