## SITTING FOR THE TRANSACTION OF COUNTY BUSINESS

THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY ("the Board") sat for the transaction of county business in formal session on June 13, 2007 at 9:00 a.m. in Room 32 of the Courthouse, Commissioners Kathy George, Mary P. Stern, and Leslie Lewis being present.

The Board discussed the possibility of setting up a meeting with DEQ and agreed to wait until after the legislative session closes.

Ms. Lewis explained that thirty acres of exception land in northeast Newberg are being considered for expansion of the Urban Reserve Area, but the majority of residents in that area are opposed to the idea and are frustrated that members of the Newberg Urban Area Management Commission seem unwilling to listen to their concerns. She expressed her own frustration that Goal 1 favors neighbors trying to stop property owners from doing something with their land, but doesn't seem to give any weight to the property owner's wishes. She stated that she plans to introduce a bill to the legislature during the 2008 session and will tell the City of Newberg that she doesn't want the Board to hold any hearings on the URA application until she sees whether or not the bill is approved.
