Rate Sheet – Ride Times

PUBLIC (Open) RIDE TIME

The Yamhill County fairgrounds feature three riding arenas. Delashmutt arena is our 100' x 100' indoor lit arena. Drader is our 100' x 130' covered lit arena. Whitman is our 140' x 240' outdoor arena. Arenas are open for open riding when not closed for private use, events or maintenance (see schedules posted on the website, outside the fair office and at the main gate to the Delashmutt arena.) The arenas are 'worked' each afternoon 2-3 PM. The arenas are available Saturday - Thursday 8:00 am – 10:00 pm, and Fridays 8:00 am – 6:30 pm when there are no private rentals or shows (Tuesday are always open for ride time i.e. no rentals or shows; the YC Sheriff's Posse often invites riders to join them or share the arena with them on Friday evenings.) All persons riding are to have their ride pass or day sticker available for presentation when asked for by fair staff (ride pass slip must be put in envelope/pay box **and** sticker placed on person.) Payments are to be placed in the pay box at the main gate to Delashmutt prior to riding **and** sticker must be placed on person. Facilities are under video surveillance.

All riders must complete and submit an 'Equine Activity Release' form prior to riding; minors must have parent or guardian signature as well. This is a time for mounted riders; no ground work in the main arena (may lunge in the outdoor warm-up arena), no gaming, no carting. The arena is available for private rental; contact the office for times and rates.

'Arena Rules' must be followed or riding privileges will be revoked.

Fees – (annual passes effective July 1st through June 30 of next year)

Daily ride fee	\$5/ horse
Individual Annual Pass	\$95/person, one horse
Family Annual Pass (same residence)	\$150/family, one horse per rider
