**Creation:** Ordinance 723, effective 10-01-03 [B.O. 03-127]  
**Membership:** Fourteen (14) members, designated positions; seven (7) members shall constitute a quorum; the committee shall elect a chairperson.  
**Terms:** 1-3 years staggered; subsequent appointments shall be for two-year terms. Members may resign or be removed by the Board; otherwise, members shall serve until their successors are appointed and qualified. Vacancies will be filled for the balance of the unexpired term. Persons may be appointed to successive terms.  
**Meetings:** The committee shall meet at such times as it deems necessary or as called by the Administrator or the Board of Commissioners.
