THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY, OREGON (“the Board”) sat for the transaction of county business in formal session on April 16, 2015, commissioners Allen Springer, Mary Starrett, and Stan Primozych being present.

WHEREAS, the Oregon Parks and Recreation Department is accepting applications for the Local Government Grant Program; and

WHEREAS, Yamhill County desires to participate in this grant program to the greatest extent possible as a means of providing needed park and recreation acquisitions, improvements and enhancements; and

WHEREAS, the Board of Commissioners have identified the acquisition of land for the Yamhelas Westsider Trail as a priority need in Yamhill County and

WHEREAS, Yamhill County seeks to acquire the railroad right of way currently owned by Union Pacific Railroad for the purpose of its development into the Yamhelas Westsider Trail, a multipurpose and mixed use transportation corridor; and

WHEREAS, Yamhill County has available local matching funds to fulfill its share of the obligation related to this grant application should the grant funds be awarded; and

WHEREAS, Yamhill County will ensure that agreements are in place with project partners to provide adequate funding for on-going operations and maintenance of this park and recreation facility should the grant funds be awarded; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY AS FOLLOWS:

- Section 1: The Board of Commissioners demonstrates its support for the submittal of a grant application to the Oregon Park and Recreation Department for acquisition of land for its conversion to the Yamhelas Westsider Trail.
- Section 2: The Board of Commissioners delegates authority to the Yamhill County Administrator to sign the application.

Section 3: This Resolution shall be effective following its adoption by the Board of Commissioners noting that Commissioners Springer and Primozich are in favor of the resolution with Commissioner Starrett opposed.

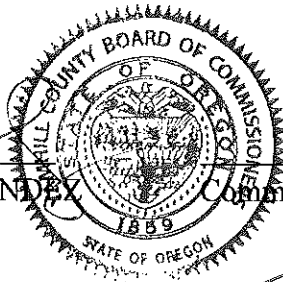
