NOTICE OF SESSION

YAMHILL COUNTY BOARD OF PROPERTY TAX APPEALS

Notice is hereby given that on Tuesday, February 12, 2019, at 3:00 o'clock P.M., the Yamhill County Board of Property Tax Appeals, will meet at the County Clerk's Office in McMinnville, Oregon to begin planning the BoPTA hearing process. Between that date and April 15, 2019, the Board will:

- Hear petitions for reduction of the real market, maximum assessed, specially assessed, or assessed value of property as of January 1, 2018, or as determined under ORS 308.146(5)(a), ORS 308.146(6)(a), or ORS 308.428.
- Hear petitions for reduction of value corrected under ORS 311.208.
- Hear petitions for waiver of penalties for late filing of real or personal property returns.

Petitions must have been filed with the Clerk of the Board or postmarked not later than December 31, 2018.

The Board will meet at the County Clerk's Office, 414 NE Evans St., in the city of McMinnville.

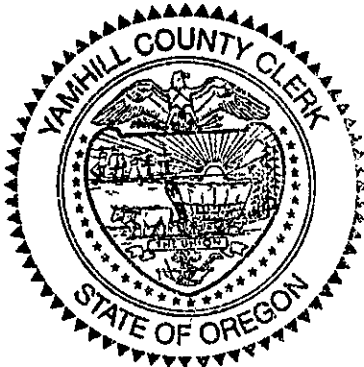
A schedule of hearings for those who request to be present will be posted at least 48 hours prior to the meetings on courthouse bulletin boards and on the County Clerk's website.
