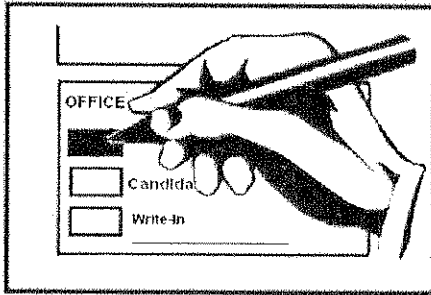

ADVISORY QUESTION ON FORMATION OF HOME RULE CHARTER STUDY COMMITTEE

QUESTION: Shall Board of Commissioners appoint a committee to consider whether a home rule charter should be submitted to county voters?

SUMMARY: ADVISORY QUESTION.

This advisory question is referred to the voters by the Board of Commissioners in the March, 2008 election. (The March, 2008 election is conducted to test new voting equipment acquired by the county, and to train elections workers on the new equipment.)

HOME RULE CHARTERS. About 9 of the 36 Oregon counties operate under "home rule charters" allowed by the Oregon Constitution and State statutes. Non "home rule" counties are typically referred to as "general law" counties. Among "home rule" counties are Multnomah and Lane. Among "general law" counties are Marion and Yamhill.

PRIOR YAMHILL COUNTY CHARTER COMMITTEES. Over the past 30 years, different county charter committees have been appointed by the Board of Commissioners. Some committees have decided not to propose a home rule charter. The most recent charter committee proposed a home rule charter, but it was rejected by the voters.

The Board will consider the results of the vote on this advisory question, but is not bound by the results.
