

EXPLANATORY STATEMENT

Approval of this measure would temporarily prohibit the establishment and operation of psilocybin-related businesses within the City of Sheridan. A city council may adopt an ordinance prohibiting the establishment of psilocybin related businesses within the city, but the council must refer the ordinance to the voters at a statewide general election. The Sheridan City Council has adopted an ordinance prohibiting the establishment of psilocybin related businesses within the City of Sheridan for a period of two years and, as a result, has referred this measure to the voters.

If approved, this measure would prohibit psilocybin-related businesses within the City of Sheridan until December 31, 2024.
