**YAMHILL COUNTY SOLID WASTE ADVISORY COMMITTEE (SWAC) ( p. 2 of 2)**

ORS 459.320 - The Board shall select members of the committee from among at least each of the following groups, to the extent feasible:

- (a) Residents residing near or adjacent to regional disposal site.
- (b) Owners of real property adjacent to or near regional disposal site.
- (c) Persons who reside in or own real property within the county in which the regional disposal site is located.
- (d) Employees of the permittee ('permittee' is defined in ORS 459.315 as a person operating a regional disposal site under a permit issued under ORS 459.245.
- (e) Local organizations and citizen interest groups whose majority of members either:
  - 1. Electors of the county in which the regional disposal site is located; or
  - 2. Own real property in the county in which the regional disposal site is located.

[SWAC applicants will need to include at least one group designation on the membership form.]
