Oregon Concealed Handgun License (CHL)

MUST BE PRESENTED IN PERSON

NEW concealed handgun license applications are accepted on **Mondays and Thursdays from 10:00 am to 4:00 pm ONLY**. Please bring your Certificate of Training.

If you take an online course, please be sure that, in addition to your legal name, the Instructor's name and NRA or Law Enforcement Certification Number is *clearly printed* on your Training Certificate.

Two forms of identification are required. One **must** be an Oregon Driver License with an address in Yamhill County; examples of acceptable second IDs include, but are not limited to, a US Passport, Costco Card, Medical Insurance Card, Military ID, Bi-Mart card, or an Employee ID Card.

NON-REFUNDABLE COSTS:

We accept cash, check, money order, or Visa/MasterCard (credit or debit).

First Time Permit	\$65.00
Permit Renewals	\$50.00
Replacement (lost, stolen, change of address, out of county transfer)	\$15.00

RENEWALS – *You may not renew your CHL any earlier than 30 days prior to your current license's expiration.* No appointment is necessary. Renewals processing is Monday – Friday, from 8:00am to 5:00pm. Your updated photo will be taken at that time.
